As part of the smart city-regions project, the RTPI supported the West Midlands Futures Project, an initiative of Futures Network West Midlands (FNWM), the West Midlands RTPI, Birmingham City University and the Centre of Urban and Regional Studies at the University of Birmingham.

Learning lessons, shaping the future

Running over two academic years, the Futures Project brought together students from Birmingham's two planning schools to consider the challenges and opportunities that the West Midlands will face over the coming years and how strategic planning could shape and respond to them.

Throughout the project, students drew on the region's extensive, practitioner experience in a programme of informal events and workshops. The first stages of the project distilled the issues and lessons from previous decades and took stock of the current situation, allowing future thinking to be built on firm foundations. In doing so, students left a shared resource of their findings for the region's planners, looking both backwards and forwards.

Stage 1: A look back at strategic planning in the West Midlands

Working in small cross-university groups, the students have produced a series of short, accessible leaflets outlining their own findings on a particular decade of strategic, crossboundary planning in the region. These can be downloaded below:

Stage 2: A vision for the West Midlands - the challenges facing the region and the shape of a future planning system

Having looked at past experiences and current strategic, cross-boundary planning practice in the region, the culmination of the programme was a workshop session where the students considered the future. During this session the students worked in groups and collectively to sketch out a vision for the West Midlands, the major challenges facing the region and some of the characteristics that a future planning system should have.

Mini conference: taking stock of strategic planning in the West Midlands

In November, the Futures Project held a mini conference at Birmingham City University to mark the end of the first year of the project and to launch the next stage to current students. The event featured a group of last year's participants presenting a summary of their work, looking back at the past experience of strategic planning in the West Midlands and PhD research on the West Midlands Green Belt. After a short break, current practitioners from Lichfield,



Wolverhampton and the West Midlands Combined Authority outlined experiences of the current state of play of strategic planning in the region. The event finished with a lively, interactive panel session with the full-house audience of students and practitioners.
